# **ARTICLES OF ORGANIZATION**

#### OF

### **BULK HILL ENTERPRISES LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **BULK HILL ENTERPRISES LLC** ("Company").

#### **ARTICLE 2 - ADDRESS**
