FIRST: The name and address of this corporation is **SUNX ENTERPRISES LLC**, 124 Red Pine Drive, Sebring, Florida 33872.

SECOND: The date of the adoption of these Articles of Dissolution is 15 October 2007.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
