

. . . .

The Manager shall focus her attention on the day to day operations of the 3 Shoney's restaurants located in the Orlando DMA (Stores #2099, #2509, and #2512).

The Manager shall properly apply for, obtain, and use permits for the sale of beer and wine at each of these 3 Shoney's restaurants, and the Manager shall supervise beer and wine sales at those restaurants.
