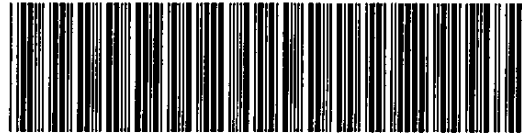

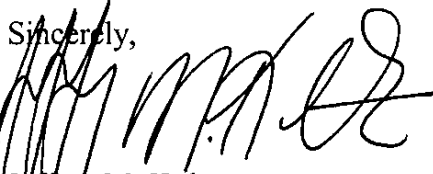
In connection with the formation of the above limited liability companies, we have enclosed the following:
