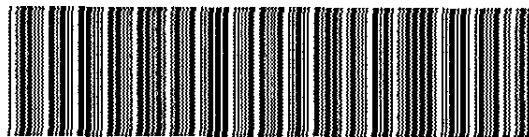



OF

A Florida Limited Liability Company

ARTICLE I  
NAME

The initial manager shall serve until the first annual meeting of the Company's members or, if later, until his successor is elected and qualifies.


ARTICLE VIII


