The undersigned subscribers to the Articles of Organization, each a natural person competent to contract, hereby associate themselves together to form a limited liability company under the provisions of Chapter 608 of the laws of the State of Florida.

#### WILLET

The name of the limited liability company is: BAC PARTNERS, LLC

#### ARTICLE II

The duration of this limited liability company shall be perpetual.

#### ARTICLE III

The initial address of the place of business in the State of Florida of this limited liability company is 9430 Silhoutte Lane, Jacksonville, Florida 32257, and the initial mailing address is the same.

#### ARTICLE IV

#### ARTICLE VIII

The date of the existence of the limited liability shall be effective January 1, 2007.

#### ARTICLE IX

The Articles of Organization of this limited liability company maybe amended in any manner permitted by Chapter 608, Florida Statutes.

#### AKTICLE X

managers who shall be elected annually by the members in the manner prescribed by and provided in the regulations of the limited liability company. The manager or managers may or may not be members. No debt shall be contracted nor liability incurred by or on behalf of this the Chability company except by one or more of its managers.
