

ARTICLES OF ORGANIZATION OF SOUTH MIAMI-SUNSET PROPERTIES, LLC

The rights accraing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
