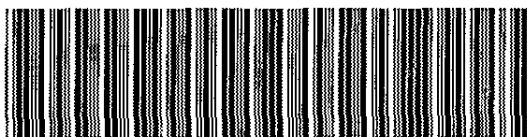

The Company shall be managed by the members.


**Article V. Limitation on Agency Authority of Members**
