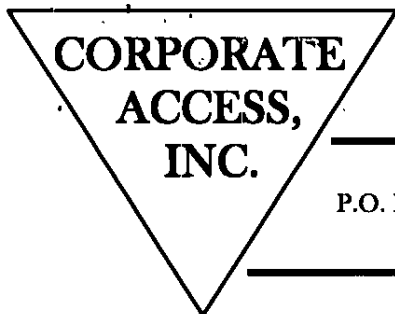

ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
OF  
MARK W. MORRIS, M.D., P.L.

The undersigned being sole Member of Mark W. Morris, M.D., P.L., a Florida professional limited liability company, (the "Company"), in accordance with the provisions of Chapters 608 and 621, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is Mark W. Morris, M.D., P.L.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective January 1, 2007.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I.  
NAME

"The name of the Limited Liability Company shall be Morris & Eisenfeld, M.D.'s, P.L."

4. These Articles of Amendment shall be effective January 1, 2011.
5. These Articles of Amendment have been approved by unanimous Written Action of the Members dated 15 OCTOBER, 2010, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
