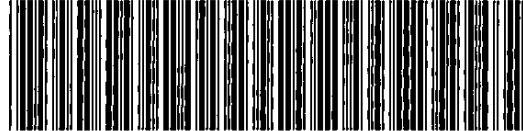

The undersigned being the Authorized Representative of a Member of FPAA-FPMS, LLC, a Florida limited liability company, (the "Company") in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is FPAA-FPMS, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective January 1, 2007.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I.
NAME


"The name of the Limited Liability Company
shall be FPAA Members, LLC."

4. This Certificate of Amendment shall be effective upon filing with the Florida Department of State.
5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
