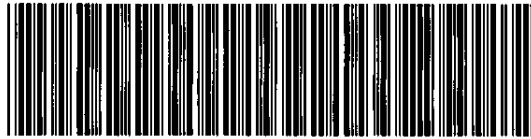

ARTICLE 1.
