Articles of Organization

A Florida Limited Liability Company

- Name. The name of this limited liability company is RCJC II LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

- Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.
- Certificated Interests. The members' interests in the Company may be evidenced by certificates.
