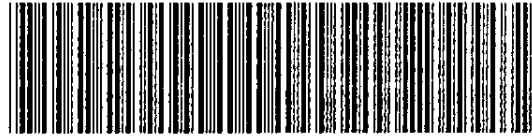

The Dissolution of the corporation or company was approved on February 1, 2011.


