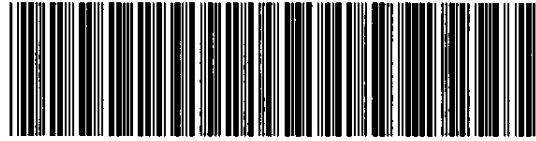

The Company is to be a manager-managed limited liability company.


