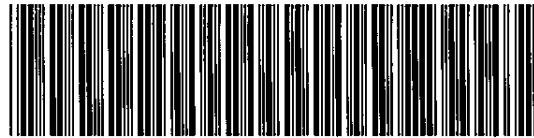

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **NO-LIST MARKETING GROUP, LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 12701 Southwest 14th Street, Unit, J203, Pembroke Pines, Florida 33027 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

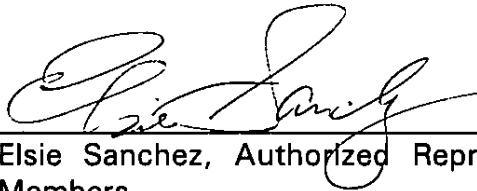

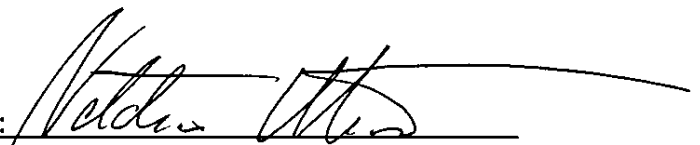
