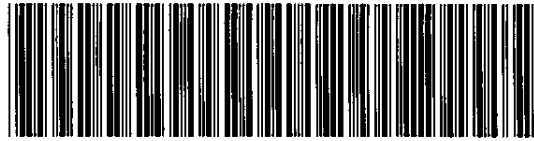

The name of the limited liability company shall be PILAR HOLDINGS, LLC (the "Company").


ARTICLE II - ADDRESS


**CERTIFICATE OF DESIGNATION OF REGISTERED AGENT
