ARTICLE IV MANAGEMENT

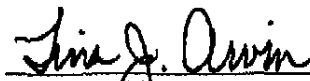
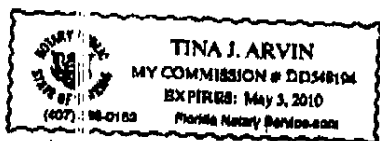
