

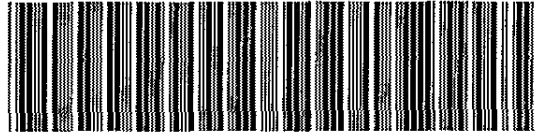

Name**


**ARTICLE V
