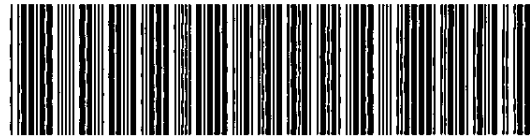

All remaining property and assets of the Company have been distributed to the Company's sole member in accordance with the sole member's rights and interests.


