The name of the limited liability company (hereinafter referred to as the "Company") is 513 Melaleuca Realty, LLC.

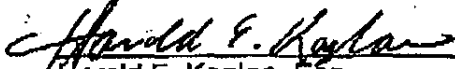

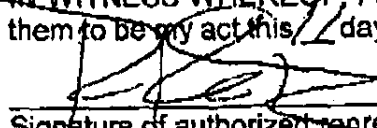
ARTICLE IV — Management:
