ARTICLES OF ORGANIZATION FOR A.G. REALTY FORT LAUDERDALE, A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I

<u>Name</u>

The name of the Limited Liability Company is: A.G. REALTY FORT LAUDERDALE, LLC.

ARTICLE II

Address

The mailing address of the principal office of the Limited Liability Company is Bay Colony Point, Ft. Lauderdale, FL 33308.

ARTICLE III

Duration

The period of duration for the Limited Liability Company shall be perpetual.

- (d) hold itself out to creditors and the public as a legal entity separate and distinct from any other entity;
- (e) prepare separate tax returns and financial statements, or if part of a consolidated group, then it will be shown as a separate member of such group;

- (f) allocate and charge fairly and reasonably any common employee or overhead shared with affiliates and maintain a sufficient number of employees in light of its contemplated business operations;
- (g) transact all business with affiliates on an arm's-length basis and pursuant to enforceable agreements;
- (h) conduct business in its own name, and use separate stationery, invoices and checks;
- (i) not commingle its assets or funds with those of any other person;
- (j) not assume, guarantee or pay the debts or obligations of any other person;
- (k) pay its own liabilities out of its own funds;
- (l) not acquire obligations or securities of its members;
- m) not pledge its assets for the benefit of any other entity or make any loans advances to any entity;
- (n) correct any known misunderstanding regarding its separate identity;
- (o) intend to maintain adequate capital in light of its contemplated business operations; and
- (p) maintain all required qualifications to do business in the state in which the Property is located.

ARTICLE IX

Effect of Bankruptcy, Death or Incompetency of a Member

The bankruptcy, death, dissolution, liquidation, termination or adjudication of incompetency of a Member shall not cause the termination or dissolution of the Company and the business of the Company shall continue.
