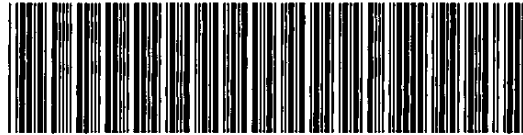

The name of this limited liability company is SPARTANBURG INVESTMENTS LLC,  
with its principal office located at 2322 McKinley St, Hollywood, Florida 33020.

**ARTICLE II**

This company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

**ARTICLE III**

The general nature of the business to be transacted by this limited liability company is as follows:

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the limited liability company may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.
- (g). To lend money for its business purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- (h). To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state.

(i). To make distribution for the public welfare or for other charitable, scientific or educational purposes.
