The undersigned, CAROL M. BUSBY, a natural person competent to contract and an authorized representative of a member of BUSBY & BUSBY CONSTRUCTION SERVICES, LLC, hereby presents these Articles of Organization as the Articles of Organization of BUSBY & BUSBY CONSTRUCTION SERVICES, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS
