**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files these Articles of Organization.

I. NAME

VII. ADMISSION OF ADDITIONAL MEMBERS

MANAGEMENT

The Operating Agreement may contain any provisions for the management of the affairs of the Company not inconsistent with law or these Articles of Organization.

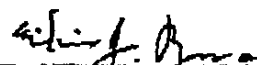
