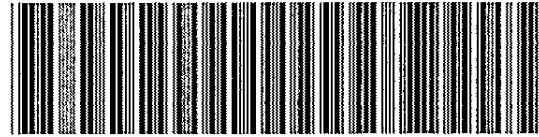

The undersigned member hereby forms this limited liability company (hereinafter referred to as "this company") under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, and adopts as the Articles of Incorporation of such limited liability company the following: -

ARTICLE I

The name of the limited liability company is:

ARTICLE II

The period of existence of this company is perpetual. The date and time at which the existence of this company begins is the date and time of filing of these Articles of Organization by the Florida Department of State.

ARTICLE III

The purpose for which this company is organized is to engage in a trucking business and any or all lawful acts or activities in which limited liability companies may engage under the Florida Limited Liability Company Act or under the laws of any other jurisdictions in which this company may conduct business.
