**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
OF  
TUHAYE RWB 35, L.L.C.  
(a Florida limited liability company)**

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the following amendments shall be made to the Articles of Organization of TUHAYE RWB 35, L.L.C., a Florida limited liability company (the "Company"), which were filed on December 21, 2006, with an effective date of December 14, 2006:

1. Article I of the Articles of Organization of the Company is hereby deleted in its entirety, and replaced with the following:

**"ARTICLE I – NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the limited liability company is TUHAYE RWB 35, L.L.C., with its principal office located at 3536 East Ridgeway Drive, Kamas, Utah 84036, and its mailing address located at 65 Venisa – Coteau du lac, Quebec Canada J0P 1B0."

2. Articles II, III, V, VI, VII and X of the Articles of Organization of the Company are hereby deleted in their entirety.

3. Article IV of the Articles of Organization of the Company is hereby deleted in its entirety, and replaced with the following:

**"ARTICLE IV - MANAGEMENT**

The limited liability company shall be managed by its sole member, Eric Roy, whose address is 65 Venisa – Coteau du lac, Quebec Canada J0P 1B0, and he shall have all powers to control and manage the business and affairs of the limited liability company and exercise all powers of the limited liability company."

4. Article VIII of the Articles of Organization of the Company is hereby deleted in its entirety, and replaced with the following:

**"ARTICLE VIII - DURATION**

The period of duration for the limited liability company began on the effective date of filing of the Articles of Organization of the Company with the Florida Department of State, and shall have a perpetual existence and duration, until terminated in accordance with applicable law or the Operating Agreement of the Company."


5. Except as hereby amended, the Articles of Organization of the Company shall remain unchanged.

6. These Articles of Amendment were duly adopted and approved by the Unanimous Written Consent of the Members of the Company on September 11, 2009.

7. These Articles of Amendment shall be effective as of December 2, 2009.
