The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Chalker Arlington, LLC (the "Company"). The Company's principal address and mailing address is 4006 West Palmira Ave., Tampa, FL 33629. The Company's initial registered agent is David M. Jeffries, whose address is 101 East Kennedy Boulevard, Suite 3000, Tampa, Florida 33602-5884. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

**Duration of Existence**




