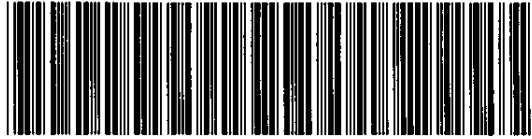

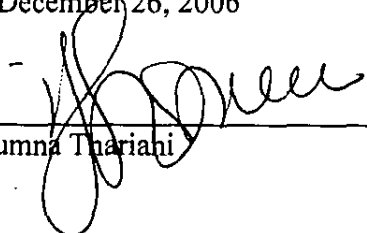
FOURTH: The mailing address and street address of the principal office of the Limited Liability Company is 3216 Butler Bay Drive North, Windermere, FL 34786.

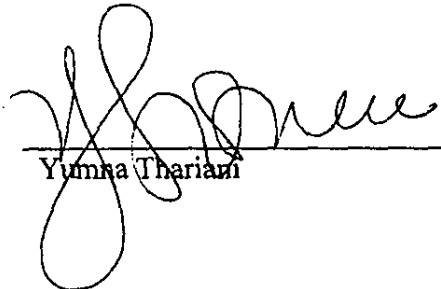
