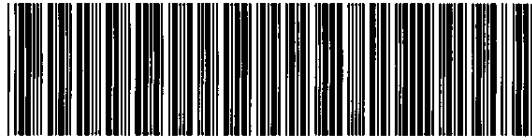

The name of the Limited Liability Company is EWE/MIAMI LAKES NO. 2, LLC (the "Company").


**ARTICLE II - Address**
