**ARTICLES OF ORGANIZATION
OF**

HEATHER M. CONGER, P.L.

The undersigned, acting as the organizer of **HEATHER M. CONGER, P.L.** under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the professional limited liability company is **HEATHER M. CONGER, P.L.** (the "Company").

ARTICLE II - Address:

The mailing address and street address of the principal office of the Company is 390 North Orange Avenue, Suite 1400, Orlando, Florida 32801.

ARTICLE III - Purpose:

The Company is organized for the purpose of engaging in the practice of law. The Company is a professional limited liability company governed by Chapter 621, Florida Statutes.

ARTICLE IV - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

ARTICLE V - Management:

The Company is to be managed by Managers, except as provided in the Operating Agreement, and the name and address of the initial Manager is:

ARTICLE VI - Admission of Additional Members:

The Company shall admit new Members only upon the unanimous written consent of all the then existing Members of the Company.

ARTICLE VII - Adoption of Operating Agreement:

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, Chapter 608, Fla. Stat. or Chapter 621, Fla. Stat.

ARTICLE VIII - Initial Registered Agent and Office:

The initial registered agent for the Company shall be B&C Corporate Services, Central Florida, Inc., a Florida corporation, and the street address of the Company's registered office is 390 North Orange Avenue, Suite 1400, Orlando, Florida 32801.

ARTICLE IX - Amendments:

The Company reserves the right to amend any provision of the Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all Members of the Company.

ARTICLE X - Indemnification:


Each individual or entity who is or was a Manager or Member of the Company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a Manager or Member of the Company ("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a member or officer existing at the time of such repeal or amendment.

ARTICLE XI – Continuation of Business:

Unless dissolved in accordance with the Company's Operating Agreement, the remaining Member or Members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member.


