**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
HEATHER M. CONGER, P.L.**

The undersigned, as the manager of Heather M. Conger, P.L., a Florida professional limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 621, Florida Statutes, the Florida Professional Service Corporations and Limited Liability Companies, states as follows:

3. The Articles of Organization of the Company are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:
