ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, NEW RIVER, LLC (the "Company") adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization were filed on January 3, 2007, and assigned Florida Document No. L07000000620.

SECOND: The Company was dissolved on December 31, 2007, and the effective date of the Articles of Dissolution was April 30, 2008.

THIRD: The revocation of dissolution for the Company was authorized in the same manner as the dissolution on May 1, 2008.

FOURTH: A new Article IV is hereby created as follows:
