

**ARTICLES OF ORGANIZATION
OF
SEC CONSULTING, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **SEC CONSULTING, LLC** ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be **SEC CONSULTING, LLC** at 2100 North Peninsula, Unit 114, New Smyrna Beach, Florida 32169, and the mailing address is 1982 St.Rd. 44, #133, New Smyrna Beach, FL 32168.

ARTICLE III -- DURATION

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT
