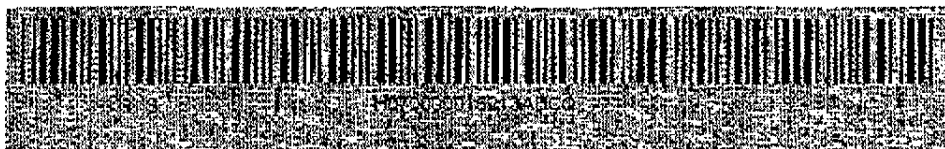


## ARTICLE VIII - ADMISSION OF NEW MEMBERS


