ARTICLES OF ORGANIZATION
OF
ARTROB INVESTMENTS, LLC

1. Name. The name of this limited liability company is **ARTROB INVESTMENTS, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company shall be effective upon the filing of these Articles and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 19011 Broken Arrow Trail, Lakeland, Florida 33813.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Arthur H. Erickson. The street address of the initial registered agent of the Company is 1901 Broken Arrow Trail, Lakeland, Florida 33813.

6. Contributions to the Company. No cash or property has been contributed to the Company by its members. No additional contributions have been agreed upon.

7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company is a manager managed company as described more fully in the operating agreement of the Company ("Operating Agreement"), and the business and affairs of the Company shall be managed by or under the direction of one or more managers (the "Manager").
