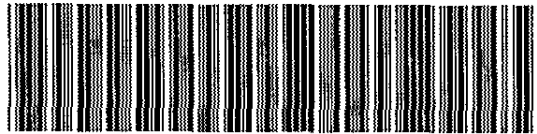

ARTICLE I - Name:


ARTICLE VI - Limitation on Agency Authority of Members:
