2<sup>nd</sup> Street Place, LLC, a Florida manager-managed limited liability company, and Dasa, LLC, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 605.1022, Florida Statutes. The terms of the Plan of Merger are as follows:

1. The names of the business entities planning to merge are 2<sup>nd</sup> Street Place, LLC, a Florida manager-managed limited liability company ("2<sup>nd</sup> Street"), and Dasa, LLC, a Florida manager-managed limited liability company ("Dasa"). As a result of the merger, 2<sup>nd</sup> Street shall be merged with and into Dasa. Dasa shall be the surviving business entity.

2. The merger shall be effective on the date the Articles of Merger are filed with the Florida Department of State (the "Effective Date").
