The existence of the Company shall begin on January 5, 2007.

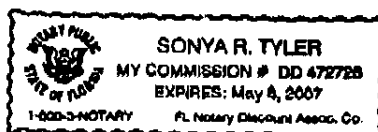

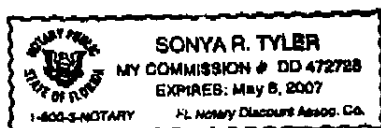
