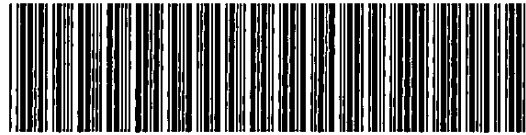



5. Management. The company shall be managed by one or more Managers as set forth in the Operating Agreement.


