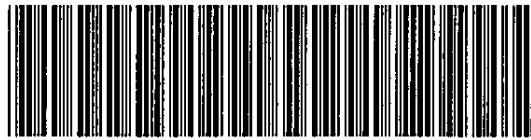



The name of the Limited Liability Company is: LW CONSULTING WORLDWIDE, LLC


**ARTICLE II**


