The name and the Florida street address of the initial registered agent are: W. Kevin Russell, 14295 S. Tamiami Trail, North Port, Florida 34287.

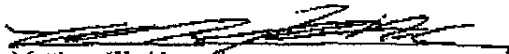
ARTICLE IV — Management:

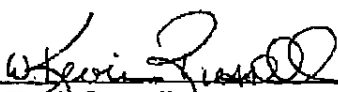
