**ARTICLES OF ORGANIZATION FOR

ARTICLE I - NAME

The name of the Limited Liability Company is **TIGER HEAD CATTLE CO., L.C.**

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 501 Pawnee Trail, Maitland, Florida 32751.

ARTICLE III - DURATION

The period of duration for the Limited Liability Company shall be perpetual, subject to earlier dissolution as otherwise provided by law.

ARTICLE IV - Management

If a Majority of the Members entitled to vote (not including the transferring Member) do not approve of the Transferring Member's proposed transfer of his Membership Interest, whether by sale, gift or otherwise, to a transferee who is not a Member immediately prior to the transfer, then the proposed transferee shall have no right to participate in the management of the business and affairs of the Company or to become a Member. Such transferee shall be merely an Economic Interest Owner.
