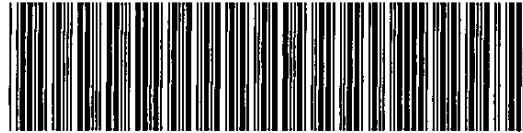

ARTICLES OF ORGANIZATION FOR KHODR, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), under the laws of the State of Florida do set forth the following:

ARTICLE I – NAME

The name of the Limited Liability Company is KHODR, LLC (hereinafter referred to as the "Company").

ARTICLE II – PERIOD OF DURATION

The period of duration of the Company shall be perpetual, unless it is dissolved as provided in the Florida Limited Liability Act or the written Operating Agreement to be executed by all of the Members of the Company.
