ARTICLES OF ORGANIZATION OF MERCEDES ANGELL, LIMITED LIABILITY COMPANY

The undersigned, acting as organizers of Mercedes Angell, LIMITED LIABILITY COMPANY, under the State of Florida Limited Liability Company Act, adopt the following Articles of Organization:

I. NAME OF COMPANY
