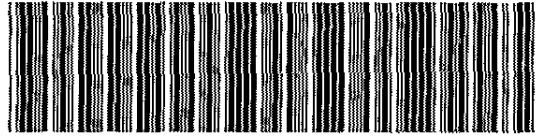

# ARTICLES OF ORGANIZATION OF EUROPEAN HAIR IMPORTS LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE 1 - NAME

The name of the limited liability company shall be **EUROPEAN HAIR IMPORTS LLC.**, ("Company").

## ARTICLE 2 - ADDRESS

## ARTICLE 5 - PURPOSES AND POWERS

The general purpose for which the Company is organized is to engage in the business of wig distribution and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




