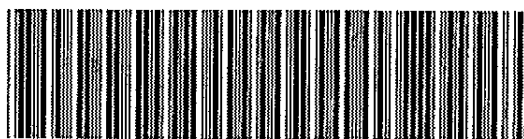

**ARTICLES OF ORGANIZATION  
FOR

A FLORIDA LIMITED LIABILITY COMPANY**

That I, **Jimmy Leon Mooney**, the undersigned organizer, for the purpose of establishing a limited liability company for the transaction of business, and the promotion and conduct of the objects and purposes hereinafter stated, under the provisions of, and subject to the requirements of the laws of the State of Florida, does hereby make, record and file these Articles of Organization, verifying that:

**ARTICLE I**

**NAME:** The name of the Limited Liability Company is **Florida Moon, L.L.C.**

**ARTICLE II**

**PRINCIPAL OFFICE:** The principal office in the State of Florida is to be located at **24441 Islewood Drive, Brooksville, Florida 34601-5359**. The mailing address is **24441 Islewood Drive, Brooksville, Florida 34601-5359**. The Company may also maintain an office at such other place within or outside the State of Florida, as it may from time to time determine. Company business of every kind and nature may be conducted; and the meetings of the Members and Managers may be held outside the State of Florida, which shall be the same as if held in the State of Florida.

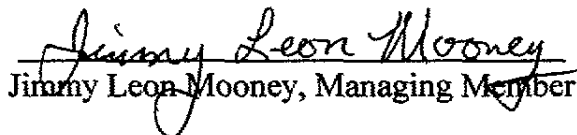
**ARTICLE V**

**ARTICLE VI**

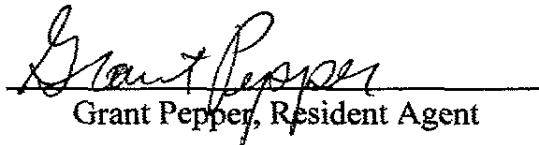

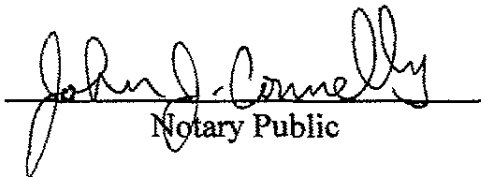
