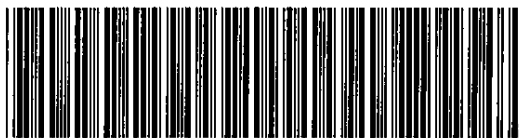



ARTICLE IV – Duration


The existence of the Company shall be perpetual.
