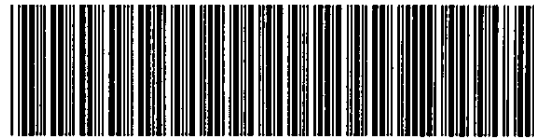

The name of the limited liability company is: Remington College of Nursing Orlando, LLC.


ARTICLE II. ADDRESS
