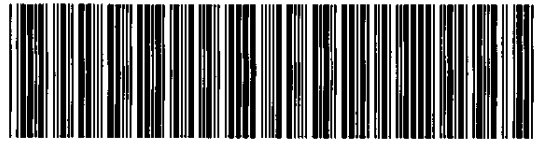

**ARTICLES OF ORGANIZATION OF
VPG LEASING, LLC**

The undersigned, being authorized to execute and file these Articles pursuant to Chapter 608, Florida Statutes, hereby certifies that:

ARTICLE I — Name

The name of the Limited Liability Company is VPG Leasing, LLC.

ARTICLE II — Address

The mailing address and street address of the principal office of the Limited Liability Company is 13802 Wright Circle, Tampa, Florida 33626.

ARTICLE III — Registered Agent

ARTICLE V — Management

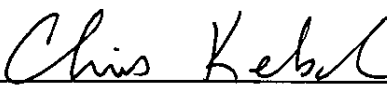

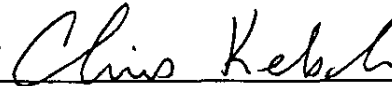
