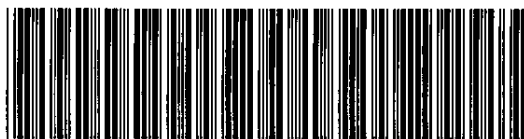

ARTICLE V- BUSINESS PURPOSE

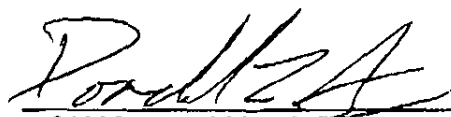
The primary business purpose of this Company is the maintenance and repair of woodworking and other machinery, in addition to any other purposes permitted under Florida law.
